Based on the decision in National Right to Work Legal Defense and Education Foundation, Inc. v. United States, 80-1 U.S.T.C. ¶9155 (E.D. N.C. 1979, and your statement that your operations are the same as during the period considered by the Court, we have determined you are exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954.

We have further determined that you are not a private foundation within the meaning of section 509(a) of the Code, because you are an organization described in section 509(a)(1) and section 170(b)(1)(A)(vi).

If your sources of support, or your purposes, character, or method of operation change, please let your key district know so that office can consider the effect of the change on your exempt status and foundation status. Also, you should inform your key District Director of all changes in your name or address.

Generally, you are not liable for social security (FICA) taxes unless you file a waiver of exemption certificate as provided in the Federal Insurance Contributions Act.
